- 1. <u>Election of Chairman</u>. It was proposed by D Sargent, seconded by C McDonnell that P Rodger be chairman there were no other nominations and he was deemed elected.
- 2. Declaration of Acceptance. Mr Rodger signed his declaration of acceptance.
- 3. <u>Vice Chairman</u> It was proposed by E Oxer, seconded by C McDonnell that D Sargent be Vice Chairman. There were no other nominations. He was appointed.
- 4. <u>Apologies</u> All members were present. Apologies were given for District Councillor Mr M.Windridge ( work) and County Councillor Mrs A Thomas ( Wedding Anniversary as had been made known at a previous meeting).
- 5. Minutes of the meeting held 15<sup>th</sup> May were approved and signed.
