#### 4 **Report from Councillor Thomas:**

Cllr Thomas sent a message to the PC to give the following information:

- The planning application for the Hemphall roundabout is now in the system;
- Long Stratton bypass and development are likely to be out for reconsultation soon in order to reach the Planning Committee by March, and this could include changes to the Hall Lane overbridge, with improved access to Morningthorpe and Fritton;
- the Children's Centre consultation has now ended if the proposals are accepted, Long Stratton would be the admin hub.

- 6 Matters arising from the minutes: Cllr Sargent will go ahead with booking the tree work on the basis of the £640 quote received; the area will also be cleared and tidied, and Cllr Sargent will clear away the wood.

### 10 Highways Issues

- The eroded roadway on Edges Lane has not been attended to clerk will follow up.
- A resident has complained by email about anti-social behaviour and speeding by a neighbour along the Common in Fritton. After detailed discussion the council concluded that this was not a Parish Council matter, but a matter which should be reported to the police if this behaviour constitutes a danger to the public. The clerk will reply to this effect, and also to remind the complainant of discussions some time ago in which the possibility was mentioned to him of setting up a voluntary Speedwatch team in the community.
- a resident has complained about a tree branch overhanging his garage from The Common; Cllr Cullum will provide Cllr Sargent's contact details, and Cllr Sargent will look into the issue.
- Speed limit signs on School Road are being obscured by overgrown hedges, which need to be trimmed. Clerk will contact Highways.
