Draft minutes of Parish Council meeting held at The Barn, Friars Farm, Morningthorpe at 7.00pm on Tuesday 11 September 2018

Public discussion: A member of the public raised concerns over a likely increase in traffic through Fritton during work on the new Hempnall Roundabout on the A140, due to start in March 2019. Could a temporary lower speed limit be imposed during this period? Cllr Thomas pointed out that the new roundabout was to be constructed to one side of the current crossroads, so disruption would only happen during the final phase of the work, which would be for a limited period.

4 Report from Councillor Thomas:

District Council:

• Collaboration between Broadland and South Norfolk continues, and the next develo[pment will be the appointment of a joint Chief Executive.

County Council:

- NCC have made an application for funding for the Long Stratton bypass, and if successful this will mean
 that NCC retain responsibility for the maintenance of the bypass. Decisions regarding the original
 applications for the developments in the area will come soon following a period of consultation, and
 could involve revision of some parts of the plans..
- Budgets are still an issue at NCC and proposals are expected soon.
- With the consultation now over, Norfolk PCC is to decide if he wishes to proceed with plans to merge the Fire and Rescue Service with the Police.

8 Planning Issues

- Cllr Sargent has received a quote from a tree surgeon for the work on two trees at the pond on Fritton Common which are causing visibility problems along that stretch of road-£640 to remove both trees and associated materials. They are both large an ash and a willow and it was agreed that these are reasonable quotes. One approach would be to deal with the trees this winter, and the pond clearout next year. Cllr Sargent will contact the SNDC Tree Officer, Robin Taylor, and also has a meeting in October with Natural England and will raise these issues with them.

BT inform us that UK Power Networks have confirmed that there is no power supply to the telephone kiosk and that it would cost us over £1,000 to have the power supply connected. Because we have no alternative location for a community defibrillator, BT Operations Manager has finally agreed that they, BT, will foot the bill. Once we have confirmation that this has been done (and they cannot promise a date as this will be up to UK Power) we can get the necessary permission from SNDC Listed Buildings.
