10 Potholes etc

Cllr Sargent will send in information about the pothole near Friars Farm (see item 4 above) which has already been reported by numerous people. Cllr Cullum has also reported potholes in the area.

11 Flooding in Fritton:

(see item 4 above). The council also noted the amount of work being carried out by individu als in the parish to improve the efficiency of drains and ditches. The pond has not overflowed but work has not been possible recently because of the wet conditions and the seasonal re strictions caused by the presence of wildlife. Cllrs Rodger and Sargent will check the ditches and culverts near the pond once circumstances allow.

Damage to Fritton Noticeboard: Damage was caused to the new noticeboard recently when BT or Openreach workers/contractors were carrying out tree work near overhead lines. The clerk attempted without success to get a response from Openreach and eventaully had to contact the CEO, whose team is now investigating. Meanwhile, the councillors say that the damage is not serious and can be repaired easily. Cllrs Rodger and Sargent will check it.
