- Report from County & District Councillors: reports were submitted by email and circulated In addition, Cllr Thomas reported on the work of the Strategic Floooding Alliance headed by Lord Dannatt, which is now working well. The Long Stratton bypass planning application, including additional drainage work, is now in the system, though its progress is currently hampered by discussions on new Nutrient Neutrality regulations. Norfolk and Suffolk Foundation Trust (Mental Health) is now in special measures.

Cllr Edney informed the council that a decision on joint accommodation for Broadland and South Norfolk admin staff will be made next week. The sum available for CAF (Community Fund) grants has been increased threefold. There are also funds available (up to the date of the next meeting) for this council and Cllr Edney will support any submissions by the council.
